WOODPRO tech LIMITED WARRANTY

- 1. 10 YEAR LIMITED WARRANTY: Wood Protection Technologies, Inc. (WPT), warrants the treatment of interior wood component(s) of a covered structure, which have been treated by a WPT authorized coating facility with the WPT Wood Preservation system consisting of one or more − FRC12 Fire Inhibitor, Disodium Octaborate Tetrahydrate (DOT) Wood Preservative and Wood Surface Film™ process, marketed as WPT3000, WPT4000 and WPT8000, under the quality controls and third party factory auditing by an ISO 17020 accredited body, as defined in DrJ Engineering Technical Evaluation Reports (TER). The WPT Wood Treated Component(s) is warranted to inhibit mold fungus growth/mycotoxin production on the cured surface of the film for 5 years; wood-rot fungi decay and wood ingesting insects (including subterranean or Formosan termites) or carpenter ants, due to the failure of WPT WoodSurfaceFilm™ treatment while owned for 10 years. Such failure must render the WPT Wood Treated Component incapable of performing its intended purpose. This Limited Warranty applies only to WPT Wood Treated Component(s), as defined above, incorporated into covered, (interior) residential and non-residential, structure construction. WPT product's used in exterior applications, (siding, trims and exterior accessories) are covered in a separate warranty.
 - a. Furthermore, WPT warrants the treatment of wood components of a covered structure for up to six
 (6) months in an unprotected vertical framed state, subject to proper documentation indicating completion of structure exterior wrapping or dry-in process.
 - b. Note: WPT will warrant the treatment of wood components delivered and stored at construction sites for (4) four months, subject to the treated wood being stored off the ground, covered in its protective cover and safeguarded from accumulation of snow or standing water or water runoff.
 - c. Subject to the Warranty Exclusions and Limitations of Liability set forth below, WPT will replace any WPT treated Component(s) that becomes unfit for its intended purpose, during the Warranty Period. The Warranty Period begins on the date of purchase. This warranty is extended to the first owner after the original builder/general contractor purchases the material and is non-transferrable.
- 2. **Wood**Pro Teck provides supervision of all its licensed applicators through online monitoring of each batch mixed to assure that the formulation is properly mixed and applied. WPT takes responsibility for the performance of the coated products provided by its licensed applicators through lumber dealers and to contractors using the product. All claims arising from failure to perform as stated in this warranty are solely the responsibility of WPT.
- 3. WARRANTY EXCLUSIONS: This Limited Warranty(s) (Warranty) does not cover, and specifically excludes, any loss or damage to any WPT Treated Component(s) that has been caused in part or whole by:
 - a. Prolonged exposure to water or moisture due to unattended leaks or mechanical system failures.
 - b. The inherent and natural characteristics of some types of wood to split, warp, buckle, bow, collapse, twist or deform.
 - c. An application or use of a WPT treated Component(s) for which it was not intended.
 - d. The performance or appearance of any additional top-coat system. These features are dependent upon quality of the top-coat and the application methods controlled by the applicator, manufacturer and subsequent maintenance detailed in the manufacturers' application guidelines.
 - e. Any exposed exterior untreated surface. WPT Wood End Cut Sealer, a wood sealer or exterior paint must be applied to prevent wicking through the end-grain. Rafter tail cuts, exposed soffits or other exterior conditions where WPT treated products are exposed to exterior conditions should be treated accordingly.
 - WPT Wood End Cut sealer should be applied to all cut ends and edges that do not directly contact or abut onto other WPT treated woods.
 - f. Improper installation of any WPT treated Component(s) or installation of such component in violation of any applicable law, rule, ordinance or code.
 - g. Negligent or improper construction of the structure.

- h. Application of WPT Wood Protection– FRC12™ Fire Inhibitor, DOT Wood Preservative and WoodSurfaceFilm™ process, to wood component(s) by anyone other than an WPT authorized facility or agent.
- Existence of Wood Destroying Basidiomycetes present on the wood surface prior to coating. Wood
 destroying Basidiomycetes attack wood cellulose below the surface starting the wood rot process,
 therefore WPT wood treatment cannot reverse this damage.
- Wind, fire, lightning, ground subsidence or settlement, earthquake, flood or hail or other acts of God.
- k. Improper installation of, defects in, or failure of any other building materials used in the structure.
- I. Surface nibbling by wood ingesting insects is acceptable.
- m. WPT treated wood products used in a residential, commercial or manufacturing structure where any chemical or biological agents have been introduced.
- n. WPT warrants that Spruce and Douglass Fir dimensional lumber, when treated with WPT 8000, will meet or exceed relevant ASTM Standards (E-84) with a Class A flame spread rating as required by the International Building Code and International Residential Code. WPT treated products are not warranted in any way against destruction from fire.
- o. Due to the Eco-Friendly nature of our treating solution, lumber knots have extreme density posing a challenge for our coating to create a cured film surface. These knot areas are isolated as well as being statistically insignificant as a percentage of surface area and therefore do not significantly impact the overall performance of WPT treated wood products.
- p. Replacement of the affected components shall be limited to the cost of the actual component plus the cost of the WPT coating and does not include any consequential damages arising from removal of the component or rebuilding of the affected area. WPT reserves the right to refund the cost of the component and coating rather than providing a replacement coated component.
- 4. WPT MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR OTHERWISE. IN NO EVENT SHALL WPT BE LIABLE FOR INCIDENTAL, CONSEQUENTIAL, SPECIAL OR INDIRECT DAMAGES. NOTHING IN THIS WARRANTY SHALL AFFECT THE DURATION OF IMPLIED WARRANTIES BEYOND THEIR CUSTOMARY DURATION OR CREATE ADDITIONAL IMPLIED WARRANTIES.
- 5. Claim Procedure Notification: To make a claim under this Limited Warranty, the owner of the Covered Structure must notify WPT or the party from whom the owner purchased the WPT Wood in writing within thirty (30) days of the actual failed WPT Wood Treated Component(s). Included in the notice must be receipts from the supplier for the purchase of the materials including purchase date and reference to the address of the affected structure. WPT reserves the right to make inspections of the affected product prior to fulfilment of the warranty obligations herein. Such notice must be sent by certified mail, return receipt requested, and must include the following information: (A) date of discovery of failed WPT Wood; (B) photo(s) of damage and (C) building owners name and contact information.
